WHEREAS, under the guidance of the Commissioner of Economic Development, site development has become a major focus of the staff, and the Commissioner has taken a lead role in the regional effort to develop more available industrial space to further capitalize on new and existing business expansion, and

WHEREAS, under the leadership and direction of the Commissioner of Economic Development business outreach has become a top priority of the department resulting in more than 500,000 engagements with the business community since the pandemic, and

WHEREAS, a major aspect of the business outreach effort continues to be the Niagara County Business Growth & Retention Program, which under the direction and facilitation of the Commissioner of Economic Development, includes meetings with 75-100 Niagara County businesses annually with participation from other economic development alliance partners, and

#### **RESOLUTION TO PARTICIPATE IN AND RECEIVE FUNDS FROM NYS FRONTLINE HEALTH CARE** WORKER BONUS PROGRAM SECOND VESTING PERIOD

WHEREAS, Governor Hochul launched the Health Care Worker Bonus Program pursuant to Part ZZ of Chapter 56 of the Laws of 2022, and

WHEREAS, the Heath Care Worker Bonus Program allows qualified employers to issue bonus payments to frontline health care workers to "recruit, retain, and reward health care and mental hygiene workers" meeting specified eligibility requirements, and

WHEREAS, the bonus amounts will be commensurate with the number of hours worked by eligible workers covered by the Health Care Worker Bonus Program during the five designated vesting periods for up to a total of \$3,000 per covered worker, and

WHEREAS, the five vesting periods will be designated as Vesting Period 1: 10/1/21 - 3/31/22, Vesting Period 2: 4/1/22 - 9/30/22, Vesting Period 3: 10/1/22 - 3/31/23, Vesting Period 4: 4/1/23 - 9/30/23, Vesting Period 5: 10/1/23 -3/31/24, and

WHEREAS, that gualified employees who work at least 20 hours but no more than 30 hours per week are eligible for a bonus of \$500, qualified employees who work at least 30 but no more than 35 hours per week are eligible for a bonus of \$1,000, qualified employees who work at least 35 hours per week are eligible for a bonus of \$1,500, and

WHEREAS, that qualified employees are eligible for up to two vesting periods and the maximum any qualified employee may receive is \$3,000, and

WHEREAS, the funds to pay for this initiative will be paid by the NYS Frontline Health Care Worker Bonus Program, and

WHEREAS, eligible frontline direct care health and mental hygiene care workers are designated by title within the regulation, and

#### RESOLUTION TO PARTICIPATE IN AND RECEIVE OFFICE OF MENTAL HEALTH (OMH) FUNDS FOR WORKER RECRUITMENT AND RETENTION

WHEREAS, Governor Hochul launched the Health Care Worker Bonus Program pursuant to Part ZZ of Chapter 56 of the Laws of 2022, and

WHEREAS, the Heath Care Worker Bonus Program allows qualified employers to issue bonus payments to frontline health care workers to "recruit, retain, and reward health care and mental hygiene workers" meeting specified eligibility requirements, and

WHEREAS, the bonus amounts will be commensurate with the number of hours worked by eligible workers covered by the Health Care Worker Bonus Program during the five designated vesting periods for up to a total of \$3,000 per covered worker, and

WHEREAS, the five vesting periods will be designated as Vesting Period 1: 10/1/21 - 3/31/22, Vesting Period 2: 4/1/22 - 9/30/22, Vesting Period 3: 10/1/22 - 3/31/23, Vesting Period 4: 4/1/23 - 9/30/23, Vesting Period 5: 10/1/23 - 3/31/24, and

WHEREAS, that qualified employees who work at least 20 hours but no more than 30 hours per week are eligible for a bonus of \$500, qualified employees who work at least 30 but no more than 35 hours per week are eligible for a bonus of \$1,000, qualified employees who work at least 35 hours per week are eligible for a bonus of \$1,500, and

WHEREAS, that qualified employees are eligible for up to two vesting periods and the maximum any qualified employee may receive is \$3,000, and

## RESOLUTION APPROVING RULES AND REGULATIONS FOR LOCAL LAW NO. 4 OF 2021

WHEREAS, Local Law No. 4 of 2021 established Solar Panel Recycling Regulations, and

WHEREAS, pursuant to Section 9 of said Local Law, the County may adopt rules as necessary for the purpose of implementing, administering and enforcing this Local Law, and

WHEREAS, Section 6 of the Local Law provides for Enforcement and Penalties should a manufacturer or Stewardship Organization not be in compliance with said Local Law, and

WHEREAS, it is necessary to implement specific rules and regulations setting forth the steps for Enforcement and Penalties under Section 6, now, therefore, be it

RESOLVED, that Rules and Regulations for Enforcement and Penalties Shall Be as Follows:

- (1) Pursuant to Section 6, Paragraph 1, the County will send a written Notice of Violation to inform the manufacturer or stewardship organization that it must submit a plan or participate in a plan within thirty (30) calendar days of the date on the Notice of Violation (NOV).
  - a. The NOV shall set forth the following:
    - i. Manufacturer Name
    - ii. Project Location
    - iii. Alleged Violation of Local Law No. 4 of 2021
    - iv. Steps required to remedy pursuant to Local Law No. 4 of 2021
    - v. Appeal Information
    - vi. County Contact Information
    - vii. Penalties/Remedies that may be assessed
  - b. The NOV shall be sent via email and certified mail to (1) the contact provided by the Stewardship Organization/Manufacturer on the submitted plan/designation form, (2) the North American Operations Office of a Manufacturer if applicable and/or (3) the Manufacturer's Headquarters.
  - c. The NOV will be copied to a project's installer/developer, the land owner and the local municipality.
- (2) Appeal of the Notice of Violation
  - a. Any Stewardship Organization or Manufacturer may appeal the NOV to the Niagara County Legislature for an opportunity to be heard regarding the alleged violations.
    - i. The appeal shall be submitted in writing, and postmarked within the 30 days as set forth under the NOV.
    - ii. The appeal shall be sent to: Niagara County Legislature, 175 Hawley Street, Lockport, New York 14094.

- iii. The appeal shall be heard within 30 calendar days after receipt of the appeal. Within five days of making its decision, the decision shall be filed in the Niagara County Clerk's Office, and sent to the appellant by certified mail.
- (3) Should no corrective action be taken within 30 calendar days of the original NOV, or in the case of denied appeal within 30 calendar days of the letter-date of the Notice of Appeal decision upholding the violation, the manufacturer or stewardship organization will be fined pursuant to Section 6 of Local Law No. 4 of 2021.
- (4) Injunctive Relief: It shall be unlawful for any Manufacturer or Stewardship Organization to violate any provision or fail to comply with any of the requirements under this law. If a Manufacturer or Stewardship Organization has violated or continues to violate the provisions of this law, Niagara County may petition for a preliminary or permanent injunction restraining the manufacturer or stewardship organization from activities which would create further violations or compelling the Manufacturer or Stewardship Organization to abate/remediate the violation.
