1. The salary of the County Treasurer shall be increased in the sum of \$1,000, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the County Treasurer shall be \$17,850.00.
2. The salary of the Public Defender shall be increased in the sum of \$300, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the Public Defender shall be \$12,738.00.
3. The salary of the Commissioner of Social Services shall be increased in the sum of \$600, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the Commissioner of Social Services shall be \$20,125.00.
4. The salary of the County Attorney shall be increased in the sum of \$300, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the County Attorney shall be \$17,340.00.
5. The salary of the Commissioners of Election shall be increased in the sum of \$600, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the Election Commissioners shall be \$11,093.00.
6. The salary of the Director of Real Property Tax shall be increased in the sum of \$600, effective 45 days after adoption of this local law. Effective January 1, 1975, the annual salary of the Director of Real Property Tax shall be \$12,455.00.




