Individuals with self-declared incomes at or above 185% of the federal poverty level (\$1,815 per month for a single person) are encouraged to contribute at levels based on the actual cost listed.

The Niagara County Office for the Aging encourages financial contributions to help pay program costs and provide the much needed services to our seniors.
